Privacy Policy

- 1. This privacy policy applies to Semaphore PR's website at www.semaphore-pr.co.uk (the "Website"). At Semaphore PR we take your privacy seriously. This policy covers the collection, processing and other use of personal data under the Data Protection Act 1998 ("DPA") and the General Data Protection Regulations ("GDPR").
- 2. For the purposes of the DPA and GDPR we are the data controller and any enquiry regarding the collection or processing of your data should be addressed to Emma Pyott at Suite 5, 137 -139 High Street, Beckenham, BR3 1AG.
- 3. By using the Website you consent to this policy. We are registered with the Information Commissioner's Office for this purpose.

Information we collect

- 4. We will collect personal data on this Website only if it is directly provided to us by you the user, e.g. your e-mail address, name, home or work address and telephone number, and therefore has been provided by you with your consent. Normally you will only provide such details if you wish to enquire about our services or sign up for our free enewsletter or other resources.
- 5. We also use analytical and statistical tools that monitor details of your visits to our website and the resources that you access, including, but not limited to, traffic data, location data, weblogs and other communication data (but this data will not identify you personally).

Use of your information

- 6. We may hold and process personal data that you provide to us in accordance with the DPA and GDPR.
- 7. The information that we collect and store relating to you is primarily used to enable us to provide our services to you, and to meet our contractual commitments to you. In addition, we may use the information for the following purposes:
 - 7.1 To notify you about any changes to our website, such as improvements or service/product changes, that may affect our service;

- 7.2 If you are an existing customer, we may contact you with information about goods and services similar to those that were the subject of a previous sale to you;
- 7.3 Where you have consented to receive our e-newsletters.

Disclosure of your information

8. We may disclose your information to regulatory bodies to enable us to comply with the law, to assist fraud protection and minimise credit risk.

Controlling the use of your data

9. If you have given us consent to use your data for a particular purpose you can revoke or vary that consent at any time. If you do not want us to use your data or want to vary the consent that you have provided you can write to us at the address detailed in clause 2 or email us at talk@semaphore-pr.co.uk at any time.

Where we store and transfer your data

- 10. As part of the services offered to you, for example through our Website, the information you provide to us may be transferred to and stored in countries outside of the European Economic Area (EEA) as we use remote website server hosts to provide the website and some aspects of our service, which may be based outside of the EEA, or use servers based outside of the EEA this is generally the nature of data stored in "the Cloud". It may also be processed by staff operating outside the EEA who work for one of our suppliers, e.g. our website server host, or work for us when temporarily outside of the EEA.
- 11. A transfer of your personal data may happen if any of our servers are located in a country outside of the EEA or one of our service providers is located in a country outside of the EEA. If we transfer or store your personal data outside the EEA in this way, we will take steps with the aim of ensuring that your privacy rights continue to be protected, as outlined in this privacy policy and in accordance with the DPA and GDPR. If you use our service while *you* are outside the EEA, your personal data may be transferred outside the EEA in order to provide you with these services.
- 12. We do not use or disclose sensitive personal data, such as race, religion, or political affiliations, without your explicit consent.

- 13. We may disclose your personal data outside of our group: (a) in the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets; and (b) if Semaphore PR's business is bought by a third party, in which case personal data held by it about its customers will be one of the assets to transfer to the buyer. However any such transfer will only be on terms that the confidentiality of your personal data is protected and that the terms of this privacy policy will continue to be complied with by the recipient.
- 14. Otherwise, we will process, disclose or share your personal data only if required to do so by law or in the good faith belief that such action is necessary to comply with legal requirements or legal process served on us or the website.
- 15. You have the right to opt out of our processing your personal data for marketing purposes by contacting us at talk@semaphore-pr.co.uk

Security

16. The transmission of information via the Internet or email is not completely secure. Although we will do our best to protect your personal data, we cannot guarantee the security of data while you are transmitting it to our site; any such transmission is at your own risk. Once we have received your personal data, we will use strict procedures and security features to try to prevent unauthorised access.

Third party links

17. You might find links to third party websites on our website. These websites should have their own privacy policies, which you should check. We do not accept any responsibility or liability for their policies whatsoever as we have no control over them.

Your rights

- 19. The DPA and GDPR give you the right to access information held about you by us. Please write to us or contact us by email if you wish to request confirmation of what personal information we hold relating to you. There is no charge for requesting that we provide you with details of the personal data that we hold. We will provide this information within one month of your requesting the data.
- 20. You have the right to change the permissions that you have given us in relation to how we may use your data.
